**Dignified Care Hospital Review: feedback and Written Notice
requesting further information by 15 August 2011**

On 14 March I published my Review 'Dignified Care? The experiences of older people in hospital in Wales', which was sent to Conwy County Borough Council, Gwynedd Council, Wrexham County Borough Council, Flintshire County Council, Denbighshire County Council and the Isle of Anglesey County Council with a covering letter and a response form. As well as presenting my findings from the Review, the report made twelve recommendations. Recommendation 5 was directed at Local Health Boards and Local Authorities jointly. It was my request that the councils mentioned above respond to Recommendation 5 jointly with Betsi Cadwaladr University Health Board, outlining how the recommendation will be complied with.

Since receiving the response from Betsi Cadwaladr UHB, my team and I have assessed the response thoroughly. We have also had help from a panel of advisors whose names are listed on our website. I was encouraged by the promising responses we received and felt that many of them showed a real desire to improve the experience of older people in hospital.

The Commissioner for Older People in Wales Regulations 2007 state that the information provided to me by Betsi Cadwaladr UHB and the six associated councils must be sufficient for me to determine whether or not my recommendations will be complied with or give sufficient explanation as to why a recommendation will not be complied with.

They also permit me to send Written Notice asking for more information from those bodies that have not yet persuaded me that my recommendations will be followed. I have received information from Conwy County Borough Council, Gwynedd Council and Wrexham County Borough Council but not from Flintshire County Council, Denbighshire County Council and the Isle of Anglesey County Council. Therefore, I am unsure whether these three councils approved the joint response sent by Betsi Cadwaladr UHB since the joint response does not explicitly say that this was the case.

Therefore, I have not been provided with enough information to fully assure me that the interests of older people in Wales will be safeguarded and promoted in relation to Recommendation 5. This letter constitutes Written Notice to Flintshire County Council, Denbighshire County Council and the Isle of Anglesey County Council requesting a joint response to Recommendation 5 with Betsi Cadwaladr UHB no later than **Monday 15 August at 5pm**. The Chief Executive of Betsi Cadwaladr UHB has also received Written Notice.

I am required to keep a register, available to the public, containing details of the recommendations and the result of further action I have taken, such as issuing Written Notice to a particular Local Authority or Local Health Board. This register will be on our website along with the

responses sent to us. The register will also be available in paper form on request.

Once I am satisfied that I have all the information needed, my team and I will be active in working to ensure that the Recommendation 5 becomes a practical reality which benefits older people in Wales.
